# HOME DEPAR TMENT

### Notification

No. DSH(AEP)-76:566.—In exercise of the powers conferred by the proviso to article 309 of the Constitution o India, read with the Government of India, Ministry of Home Affairs, Notification G.S.R. Chandigarh, namely:—

No. 3267, dated the Ist November, 1966, the Chief Commissioner, Chandigarh, hereby makes the following rules regulating the method of recruitment to the various Class III posts in the Food and Supplies Department

- 1. Short title and commencement.—(i) These roles may be called the Chandigarh Food and Supplies Department, Service (Class III) Recruitment Rules, 1976.
- (ii) They shall come into force at once
- 2. Application.—These rules shall apply to the posts specified in column 1 of the Schedule annexed to these rules.
- 3. Number, classification and scales of pay.—The number of posts, their classification and the scales of pay thereof shall be as specified in columns 2,3 and 4 of the said Schedule.
- 4. Method of recruitment, age-limit and other qualifications etc.—The method of recruitment, age limit, qualifications and other matters connected therewith shall be as specified in columns 5 to 13 of the said

Provided that the upper age limit prescribed for direct recreatment may be relaxed in the case of depart-mental candidates and candidates belonging to Scheduled Castes and Scheduled Tribes and other special categories of persons in accordance with the general orders issued from time to time by the Central Government.

- 5. Disqualification.—(i) No person who has more than one wife living or who having a spouse living marries in any case in which such marriage is void by reasons of its talling place during the lifetime of such spouse, shall be eligible for appointment to the said posts; and
- (ii) No woman, whose marriage is void by reason of her husband having a wife living at the time of such marriage, or who has married a person who has a wife living at the time of such marriage, shall be eligible for appointment to the said posts:

Provided that the Chief Commissioner may, if he is satisfied that there are special grounds for so ordering, exempt any person from the operation of this rule.

6. Power to relax.—Where the Chief Commissioner is of opinion that it is necessary or expedient so to do, he may by order, for reasons to be recorded in writing relax any of the provisions of these rules in respect of any class or category of persons.
