3(2) "A person shall not be qualified for appointment as a member unless he is of not less than forty years of age and possesses-

For Judicial Member

(a) an experience of at least ten years as presiding officer of a district court or of any tribunal at equivalent level or combined service as such in the district court and tribunal.

or

For Non- Judicial Member

(b) A bachelor's degree from a recognised university and is a person of ability, integrity and standing, and has special knowledge and professional experience of not less than twenty years in consumer affairs, law, public affairs, administration, economics, commerce, industry, finance, management, engineering, technology, public health or medicine:

All other terms and conditions of the appointment of a Member shall be governed by the Consumer Protection Act, 2019 as well as the Consumer Protection (Qualification for appointment, method of recruitment, procedure of appointment, term of office, resignation and removal of the Presidents and members of the State Commission and District Commission) Rules, 2020 available at website www.chdfood.gov.in.

Tenure: -

The appointment shall be on whole time basis for a term of 4 years or up to the age of 65 years, whichever is earlier and as per provisions of Consumer Protection (Qualification for appointment, method of recruitment, procedure of appointment, term of office, resignation and removal of the President and Members of the State Commission and District Commission) Rules 2020 which are made under the provisions the Consumer Protection 2019.

Other Important Information: -

- The applicants are required to submit their applications in the prescribed form which is annexed as Annexure-I, ensuring the following aspects:
 - i. In case of serving officials: -
 - (a) Applicant must submit 'No Objection Certificate' from his present employer.
 - (b) In case any departmental or any other proceedings including criminal has been initiated, pending or decided in the past against the applicant under relevant Service Rules, details of the same may be furnished.

Selection of the Members of the State Commission will be made by the Selection Committee prescribed in the Rule 6 of the Consumer Protection (Qualification for appointment, method of recruitment, procedure of appointment, term of office, resignation and removal of the Presidents and Members of the State Commission and District Commission) Rules, 2020 which are made under the provisions of the Consumer Protection Act 2019.
 - 3. Salary will be paid to the appointed Member as per Chandigarh Consumer Protection (salary, allowances and conditions of service of President and Members of the State Commission and District Commission) Rules, 2021.
 - 4. Every appointment of a Member shall be subject to submission of a certificate of physical fitness signed by a Civil Surgeon or District Medical Officer to his/her medical fitness.
 - 5. Before appointment, the selected candidate shall have to furnish an undertaking that he does not and will not have any such financial or other interest as is likely to affect prejudicially his functions as such Member.

Oaths of office and secrecy: -

Every person appointed to be a Member, before entering upon his office make and subscribe to an oath of office and secrecy in Forms I and II annexed to Rules 2020 ibid.

Declaration of Financial and other interest: -

A Member, before entering upon his office, declare his assets, and his liabilities and other interests.

Disqualifications: -

A person shall be disqualified for appointment as a Member of State Commission, if he: -

- has been convicted and sentenced to imprisonment for an offence which involves moral turpitude; or
- ii. has been adjudged as an insolvent; or
- iii. is of unsound mind and stands so declared by a competent court, or
- iv. has been removed or dismissed from the service of the State Government or Central Government or a body Corporate owned or controlled by such Government; or
- v. has, in the opinion of the State Government, such financial or other interest as is likely to prejudicially affect his functions as a Member.

Applications complete in all respects with requisite documents attached must reach in the office of the Joint Secretary, Department of Consumer Affairs, Chandigarh Administration, U.T., Secretariat, Sector-9, Chandigarh, latest by 13th October, 2021 by 5.00 P.M. It is made clear that the candidates must apply as per the format given below, failing which their application will not be entertained.
